This policy and statement sets out the arrangements made for external and independent providers gaining access to our college students for the purpose of providing careers information, advice and guidance or providing information to students in regards to additional education or training in preparation for Post 16 and Post 18. This complies with the College's legal obligations under section 42B of the Education Act 1997.

Student Entitlement

All students in Years 7-13 are entitled to:

- To find out about vocational and technical qualifications, traineeships, new 'T' Levels and apprenticeship opportunities as part of the Brixham College careers information, advice and guidance at Post 16 and Post 18.
- To gain access to local and independent providers, in order to explore the opportunities that they can offer through appropriate access events via the Personal Development curriculum.
- To provide information, advice and guidance on when to and how to apply for these types of post 16/18 opportunities.

Management of External Provider Access Requests

Protocol

To ensure that external providers are able to provide appropriate and quality independent information, advice and guidance to all our students; in the first instance contact is to be made via the member of the Senior Leadership Team responsible for CEIAG at Brixham College.

Opportunities for Access

Brixham College supports all our students to be fully informed and able to make well informed decisions that will benefit their future education and careers pathways. The College will provide students with access to Post 16/18 materials including:

College and University prospectuses, Apprenticeship and Traineeship materials/literature and any other display information linked to national and international training and education schemes where appropriate.

In addition, a range of opportunities through the Personal Development curriculum including Values sessions, assemblies, Focused Learning Days and other targeted events will ensure that these independent providers are able to inform students appropriately. Any request for this type of access must be made to the above SLT Careers Lead.

The Careers Lead may also approach independent providers, to provide their information advice and guidance at specific events, where both students and parents/carers can be present.
